### **Benefit Enhancements**

## ElevateHealth Options now available on exchange -

ElevateHealth Options plans will be available to on- and off-exchange members for 2021. These plans provide access to Harvard Pilgrim's full network of health professionals and hospitals. Tier 1 includes providers in our ElevateHealth network, and Tier 2 includes other Harvard Pilgrim participating providers throughout New England.

**Unlimited acupuncture and chiropractic visits –** Members have unlimited acupuncture and chiropractic care visits for the calendar year. Applicable cost sharing will still apply, according to the member's plan.

#### Over-the-counter prescriptions available -

Some OTC drugs are being added into our prescription drug formularies. Those therapeutic drug classes include cough, cold and allergy; dermatology; gastrointestinal; pain; and ophthalmic preparations.

## Virtual fitness subscriptions included in \$300

**reimbursement –** Members are eligible to receive up to \$300 in an annual fitness reimbursement on fees for health and fitness club memberships, classes or virtual subscriptions! Each plan member (up to two individuals) can receive up to \$150.\*

No cost sharing for Doctor On Demand urgent care visits for non-HSA plans – Members enrolled in non-HSA plans are not required to pay cost sharing for urgent care virtual visits with Doctor On Demand providers. Members on HSA plans will pay cost sharing up to the deductible amount.

**Reduce My Costs offered on all plans –** Members have access to this voluntary program, which helps find lower-cost outpatient procedures and diagnostic tests and then rewards them for choosing a more affordable option.

- Consumer Sales will continue to support changes via phone
- Off-Exchange subscribers will be automatically renewed into their 2021 plan if they do not make a change and continue to pay their monthly premium by the first of each coverage month

#### On Exchange

- On-Exchange plan changes and financial updates must be completed on www.healthcare.gov
- On-Exchange subscribers will be automatically renewed into their 2021 plan if they do not make a change and continue to pay their monthly premium by the first of each coverage month

## **Auto Payment Process**

If an existing subscriber is currently enrolled in autopay, their withdrawal will be adjusted to reflect the new 2021 premium. The subscriber does not need to take any action to change the withdrawal amount. If the subscriber has not set up autopay but would like to, they should refer to the instructions enclosed in their monthly invoice to help them get started.
