

Harvard Pilgrim Health Care is committed to ensuring that all our members have adequate access to quality care. Harvard Pilgrim maintains specific member access standards for the number and geographic distribution of primary care providers, high-volume/high-impact specialists, and behavioral health providers.

These standards, which Harvard Pilgrim reviews annually, apply universally to all plans, but vary by state/service area to adapt to each one's unique state requirements and geographic mileage criteria. We analyze our provider network's compliance with the member access standards on a quarterly basis.

Currently, Harvard Pilgrim offers plans in Massachusetts, New Hampshire, Rhode Island, and Maine. In conjunction with state regulations, Harvard Pilgrim's access standards for Exchange and non-Exchange plans are:
