What is the overall <u>deductible</u>?	Medical & <u>Prescription Drug Deductible</u> : In-Network: \$7,200 member / \$14,400 family Out-of-Network: \$14,400 member / \$28,800 family Benefits are administered on a calendar year basis.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this plan begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u>?	Yes. In-Network <u>preventive care</u> certain preventive drugs, and routine eye exams are covered before you meet your <u>deductible</u> . What is not included in the <u>out-of-pocket limit</u> ?
