If you have other family members on the policy, they have to meet their own individual deductible until the overall family deductible amount has been met.
Are there services covered before you meet your deductible ?	Yes. Preventive care , provider office visits, Tier 1 and Tier 2 services, emergency room care , emergency medical transportation , outpatient mental health services, Rehabilitation services, Habilitation services, durable medical equipment , and routine eye exams are covered before you meet your deductibles .	This plan covers some items and services even if you haven't yet met the deductible amount. But, a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible . What is the out-of-pocket limit for this plan ?	\$3,500 member / \$7,000 family Benefits are administered on a calendar year basis. What is not included in the <u>out-of-pocket limit</u> ?	<u>Premiums</u> , <u>balance-billing</u> charges, and health care this <u>plan</u> doesn't cover.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .
Will you pay less if you use a <u>network provider</u> ?	Yes.
