If you have other family members on the policy, they have to meet their own individual <u>deductible</u> until the overall family <u>deductible</u> amount has been met.
Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care</u> , <u>provider</u> office visits, Tier 1 services, Tier 2 Pediatric services, <u>emergency room care</u> , <u>emergency medical transportation</u> , outpatient mental health services, <u>Rehabilitation</u> services, <u>Habilitation</u> services, <u>durable medical equipment</u> , and routine eye exams are covered before you meet your <u>deductibles</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But, a <u>copayment</u> or <u>coinsurance</u> may apply.
