What is the overall deductible?	Medical & Prescription Drug Deductible: \$2,000 member / \$4,000 family Benefits are administered on a Plan Year basis.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this plan begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. Preventive care, provider office visits, services from Flex Providers, Tier 1 prescription drugs, Non-hospital based imaging, Rehabilitation services and Habilitation services are covered before you meet your deductible.
