If you have other family members on the policy, they have to meet their own individual <b>deductible</b> until the overall family <b>deductible</b> amount has been met.
Are there services covered before you meet your <b>deductible</b> ?	Yes: <b>Preventive care</b> , <b>provider</b> office visits, <b>emergency room care</b> , Tier 1 services, Tier 2 Pediatric services, Non-Hospital based diagnostic testing and imaging, outpatient mental health services, <b>Rehabilitation</b> services, <b>Habilitation</b> services, and routine eye exams are covered before you meet your <b>deductibles</b> .
