Generally you must pay all the costs up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the policy, they have to meet their own individual <u>deductible</u> until the overall family <u>deductible</u> amount has been met.
Are there services covered before you meet your <u>deductible</u> ?	Yes: In-Network durable medical equipment, emergency room care, prescription drugs, outpatient mental health services, preventive care, provider office visits, routine eye exams, are covered before you meet your deductibles.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But, a <u>copayment</u> or <u>coinsurance</u> may apply. Does this plan meet the Minimum Value Standard? Yes
