What is the overall deductible?	In and Out-of-Network Combined: \$500 member/\$1,000 family Benefits are administered on a calendar year basis.	Generally you must pay all the costs up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the policy, they have to meet their own individual <u>deductible</u> until the overall family <u>deductible</u> amount has been met.
Are there services covered before you meet your deductible?	Yes: In-Network durable medical equipment, emergency room care, prescription drugs, outpatient mental health services, preventive care, provider office visits, routine eye exams, are covered before you meet your deductibles.
