# Schedule of Benefits

Please Note: This Plan includes a tiered provider network called the CCHC DPO Plan (POS) network. In this Plan, Members pay different levels of Deductibles, Copayments, or Coinsurance depending on the tier of the provider delivering a covered service or supply. This Plan may make changes to a provider's benefit tier annually on January 1st. Please consult the CCHC DPO Plan (POS) Provider Directory or visit the provider search tool at www.harvardpilgrim.org/cchc to determine the tier of providers in the CCHC DPO Plan (POS) network.

This Schedule of Benefits states any Benefit Limits and the Member Cost Sharing amounts you must pay for Covered Benefits. However, it is only a summary of your benefits. Please see your Benefit Handbook for details. Your Member Cost Sharing may include a Deductible, Coinsurance, and Copayments. Please see the tables below for details.

This Plan does not provide coverage for outpatient prescription drugs. Your coverage for prescription drugs is administered by a third party called MaxorPlus. If you have questions regarding your pharmacy coverage, MaxorPlus can be reached at 1-800-687-0707.

## There are two levels of coverage - In-Network and Out-of-Network

**In-Network** coverage applies when Covered Benefits are provided or arranged by your Primary Care Physician (PCP) in the Service Area, or provided by a Plan Provider outside of the Service Area.

Out-of-Network coverage applies when Covered Benefits are provided by a Non-Plan Provider or provided by a Plan Provider without a Referral when a Referral is required. If a Non-Plan Provider charges any amount in excess of the Allowed Amount, you are responsible for the excess amount.

In a Medical Emergency you should go to the nearest emergency facility or call 911 or other local emergency access number. Your emergency room Member Cost Sharing is listed in the tables below.

#### **Prior Approval**

Prior Approval is required for certain benefits. #### Tiered Providers — In-Network

In-Network acute hospitals and Plan Providers are placed into one of two benefit levels or "tiers." Member Cost Sharing for these providers depends upon the tier in which the provider is placed. Tier 1 is the lower cost tier. Tier 2 is the higher cost tier. In some cases, a provider may practice at more than one location and may have a different tier assigned to each location. Keep in mind that different out-of-pocket costs may apply to the same provider based upon where you are treated by that provider.

You can lower your out-of-pocket cost by selecting the physicians and hospitals in the lower tier. The tables set forth below list the Member Cost Sharing for each type of tiered service. The Plan's Provider Directory lists all Plan Providers and their associated tiers. You can access the Provider Directory at **www.harvardpilgrim.org/cchc**. You may also obtain a paper copy of the directory, free of charge, by calling Harvard Pilgrim's Member Services Department at 1-844-516-5791.

Because Member Cost Sharing is dependent upon the tier placement of a doctor or hospital. you will have lower out-of-pocket costs when you select providers from the lower tier. You should consider a provider's tier and where the provider has hospital admitting privileges before selecting a provider. For example, if you require hospital care with a Tier 1 physician who performs your service at a Tier 1 hospital, you will pay the Tier 1 out-of-pocket costs for both your physician and hospital care. However, if you require hospital care with a Tier 1 physician who performs your service at a Tier 2 hospital, you will pay the lower Tier 1 out-of-pocket costs for the physician services but the higher Tier 2 out-of-pocket costs for hospital care.

#### **Covered Benefits**

Your Covered Benefits are administered on a Calendar Year basis. Your Member Cost Sharing will depend upon the type of service provided and the location the service is provided in, as listed in this Schedule of Benefits. For example, for services provided in a physician's office, see "Physician and Other Professional Office Visits." For services provided in a hospital emergency room, see "Emergency Room Care." For Inpatient hospital care, see "Hospital — Inpatient Services," and for outpatient surgical procedures, please see "Surgery - Outpatient."

When you receive a service at your home (other than home health care), your Member Cost Sharing will be the same as when the service is provided in an office or facility. For example, if you have a physician visit in your home, see "Physician and Other Professional Office Visits." If you have blood drawn at home, see "Laboratory, Radiology and Other Diagnostic Services."

Any of the following types of programs: Health resorts, spas, recreational programs, camps, outdoor skills programs, therapeutic or educational boarding schools, educational programs for children in residential care, self-help programs, life skills programs, relaxation or lifestyle programs, and wilderness programs (therapeutic outdoor programs). • Massage therapy. • Myotherapy.

#### **Dental Services**

 Dental Care, except when specifically listed as a Covered Benefit.
