Are there services covered before you meet your <u>deductible</u> ?	Yes: <u>durable medical equipment</u> , <u>emergency room</u> <u>care</u> , <u>emergency medical transportation</u> , prescription drugs, outpatient mental health services, <u>preventive care</u> , <u>provider</u> office visits, <u>rehabilitation services</u> , <u>habilitation</u> <u>services</u> , routine eye exams, are covered before you meet your <u>deductibles</u> . If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limit</u> until the overall family <u>out-of-pocket limit</u> has been met.

What is not included in the out-of-pocket limit?	Premiums , balance-billing charges, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit.
