LCU MD Roster Reporting

This report enables users to view MD information about primary care and specialty practitioners within the contracted group. Accurate provider rosters impact many critical business processes, including cost & utilization reporting, member attribution, clinical reporting, and performance based payments (for eligible groups) on P4P measures with MD participation components.

HPHC provides both a **roster report** and a **provider change report** to identify the status of recent change requests

1.0 Introduction

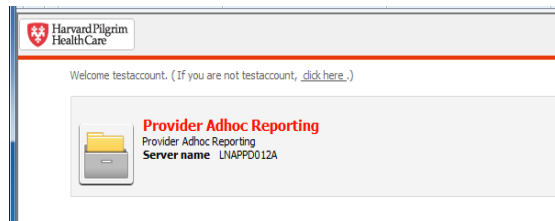
This user guide introduces staff within our provider groups to the new HPHC tools to:

- **LCU Roster Report** identifies active MDs HPHC has affiliated with their group.
- **Weekly Provider Change Report** enables reporting to an LCU on the status of provider-related additions, changes, and terminations that have been submitted to Harvard Pilgrim's Provider Processing Center (PPC)

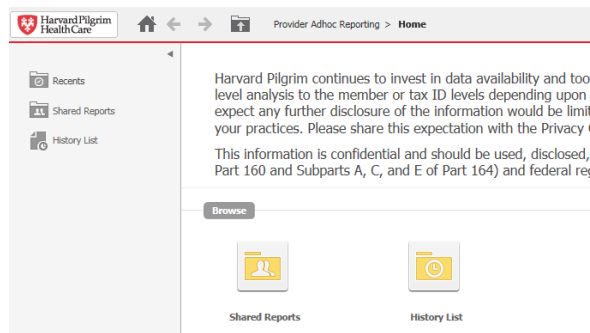
2.0 Navigating to the LCU Roster Reports folder

It is HPHC policy to adhere to the principle of minimally necessary. Only Business Users whose business role requires the use of the full TaxID number (TIN) should access it, otherwise please choose masked TIN option.

Once you are connected to the reporting suite, you will see the following screen with “**Provider Adhoc Reporting**” (PAR) folder.



Click on the “Provider Adhoc Reporting” icon and you will see the following screen. Select **Shared Reports** icon.

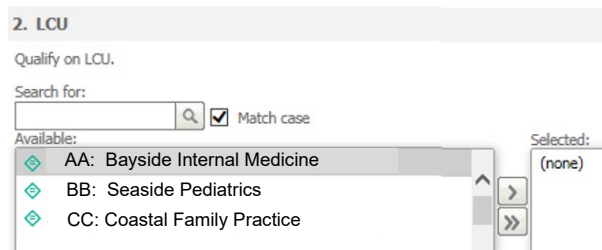

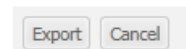
