<b>Minimum Participation/ Penalties</b>  (We strongly recommend reviewing with any provider prior to booking. <b>Decision lead time</b>	Clinics are booked based on first come first serve. However, NE Nurses aims to best meet the requested date and time of the account.	6 weeks prior to event date, however, LES actively schedules flu clinics. <b>Insurances accepted</b>	NE Nurses accepts several insurances and continues to seek additional contracts. Consult with NE Nurses for full list.	HPHC members must display a valid HPHC ID card at the time of service, for fees to process through claims. Non-HPHC members can provide another insurance card (LES-accepted plans only). <b>What information is required for setting up the onsite flu clinic?</b>	You may complete the form at Schedule a Flu Clinic - New England Nurses. ### Retail Pharmacy Options

Accounts may also choose to partner with a local pharmacy. Participating pharmacies in HPHC's retail pharmacy network are contracted through OptumRX to provide seasonal flu shots for members 3\* and older (e.g., at a retail location of Rite Aid, Walgreens etc.)

- Age recently changed due to state mandate for all school aged children to receive flu vaccine, as part of a COVID protocol. Age is normally 19 and older.
  - Accounts should call ahead to confirm a flu clinic's schedule and participation with HPHC, as well as the provider's participation in the Member's network if the Member's product has a limited network.
  - Pharmacies may offer a voucher program for use at their retail locations, and/or the option of providing an onsite worksite clinic.
- Members must have their Insurance ID card at the point of service.

Agreements for 2025-2026 Onsite seasonal Flu Clinics are between the chosen provider and your account. HPHC cannot process roster billing or retroactive claim re-adjudication for these Optum contracted retail pharmacies.

Some pharmacies can provide marketing material as well as acceptance of insurances other than HPHC, and they may provide electronic sign-ups and consents.
