What is the overall <a href="#">deductible</a> ?	Medical & <a href="#">Prescription Drug Deductible</a> : \$7,500 member / \$15,000 family Benefits are administered on a calendar year basis.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this plan begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">Preventive care</a> , <a href="#">provider</a> office visits, Tier 1 <a href="#">prescription drugs</a> , <a href="#">Rehabilitation services</a> , and <a href="#">Habilitation services</a> are covered before you meet your <a href="#">deductible</a> . What is not included in the <u>out-of-pocket limit</u> ?	Pediatric Dental Care, <u>premiums</u> , <u>balance-billing</u> charges, and health care this <u>plan</u> doesn't cover.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .
Will you pay less if you use a <u>network provider</u> ?	Yes.
