What is the overall <u>deductible</u> ?	<p>Medical & <u>Prescription Drug Deductible</u>: Tier 1: \$450 member / \$900 family Tier 2: \$700 member / \$1,400 family Benefits are administered on a calendar year basis.</p>	<p>Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this plan begins to pay. If you have other family members on the <u>plan</u>, each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u>.</p>
Are there services covered before you meet your <u>deductible</u> ?	<p>Yes. <u>Preventive care</u>, Tiers 1, 2, and 3 <u>prescription drugs</u>, and the following Tier 1 <u>Provider</u> services: <u>provider</u> office visits, <u>Rehabilitation services</u>, and <u>Habilitation services</u> are covered before you meet your <u>deductible</u>.</p>	<p>This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount.
