Are there services covered before you meet your deductible?	Yes. Preventive care, Tiers 1, 2, and 3 prescription drugs, and the following Tier 1 Provider services: provider office visits, Rehabilitation services, and Habilitation services are covered before you meet your deductible.	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply.
