What is the overall deductible?	Medical & Prescription Drug Deductible: \$7,500 member / \$15,000 family Benefits are administered on a calendar year basis.	Generally, you must pay all of the costs from <b>providers</b> up to the <b>deductible</b> amount before this plan begins to pay. If you have other family members on the <b>plan</b> , each family member must meet their own individual <b>deductible</b> until the total amount of <b>deductible</b> expenses paid by all family members meets the overall family <b>deductible</b> .
Are there services covered before you meet your deductible?	Yes. Preventive care, Tiers 1 and 2 prescription drugs, provider office visits, Rehabilitation services, and Habilitation services are covered before you meet your deductible.	This plan covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply.
