What is the overall <u>deductible</u> ?	In-Network: \$4,000 member / \$8,000 family Out-of-Network: \$8,000 member / \$16,000 family Benefits are administered on a Plan Year basis.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this plan begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. Tiers 1 and 2 <u>prescription drugs</u> , and the following In-Network services: <u>preventive care</u> , and routine eye exams are covered before you meet your <u>deductible</u> .
