Generally you must pay all the costs up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. Prescription drugs, emergency room care, and the following In-Network services: preventive care, provider office visits, Non-hospital based imaging, Rehabilitation services, and Habilitation services and services from Flex Providers are covered before you meet your deductible.
