What is the overall deductible ?	Medical & Prescription Drug Deductible: Tier 1: \$2,500 member / \$5,000 family Tier 2: \$7,000 member / \$14,000 family Benefits are administered on a calendar year basis.	Generally you must pay all the costs up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Preventive care , Tiers 1, 2, and 3 prescription drugs, and the following Tier 1 Provider services: provider office visits, Rehabilitation services , and Habilitation services are covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But, a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	No.	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan ?	\$9,100 member / \$18,200 family	The out-of-pocket limit is the most you could pay in a year of covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limit until the overall family out-of-pocket limit has been met.
