What is the overall deductible?	\$2,500 member / \$5,000 family Benefits are administered on a calendar year basis.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this plan begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. Preventive care, prescription drugs, provider office visits, Non-hospital affiliated facility day surgery, Non-hospital based laboratory and imaging, and Rehabilitation services, and Habilitation services are covered before you meet your deductible.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. What is not included in the out-of-pocket limit?	Pediatric Dental Care, premiums , balance-billing charges, and health care this plan doesn't cover.
